Terms & Conditions

1. A \$500 retainer fee and signed contract are required at the time of booking to reserve your wedding date and photo session.
2. All retainer fees are non-refundable in the event of a date change or wedding cancellation for any reason.
3. A \$0.65/ km travel fee will be applied to location shoots outside of the Hamilton/Burlington & Niagara city limits.
4. Please allow 4 - 6 weeks from the date of your wedding for your first viewing of wedding proofs.
5. Due to the artistic nature of wedding photography, completion dates are tentative; however, every effort will be made to remain within schedule.
6. Current rates are guaranteed to all orders received within six months of the wedding date.
7. Additions but not deletions can be made to orders in progress.
8. The length of time a photograph retains its original quality depends on, among other things, the environment in which it is displayed or stored. To preserve the longevity of your photographs store them in a cool dry environment away from direct sunlight and in an acid free album or matte.
9. All work is guaranteed as to photographic quality and craftsmanship. PATTINSON STUDIO Photography Services shall not be held responsible for non performance due to mechanical failure, theft, acts of God, or any circumstances beyond its control. The studio's liability is strictly limited to the return of monies received.
10. All permits required will be obtained/paid for by the client.
11. It is understood that PATTINSON STUDIO is the exclusive & official photographers retained to perform the photographic services requested on this contract.
12. In the event that a client/party are unreasonable or hard to work with at any time, the Studio/Photographer reserves the right to return the retainer fee and payments made. The studio/photographer shall have no further liability with respect to the contract to photograph the wedding.
13. Services beyond the terms of this contract including overtime caused by delays not within the control of the studio will be charged at \$150/ hour.
14. The studio reserves the right to use negatives (digital or film)/photos and/or reproductions for purposes of display, exhibitions, contests, advertising, publication and other purposes. Negatives (digital or film)/photos remain the exclusive property of PATTINSON STUDIO. The client has the right to print for personal use 4x6" prints only; enlargements of 5x7" or larger must be obtained through PATTINSON STUDIO. It is illegal to copy/reproduce any of the studio/photographer's photos without the express permission of the studio/photographer.
15. The Studio/photographer can not be held responsible for the quality of photographs developed/printed from the DVD, as the quality varies greatly depending on the quality of printing/developing process and paper. Photographs developed by the studio are guaranteed to be high quality.
